Appeal for restoration of democratic institutions, the promotion of peace and human rights, and the protection of civic space in Nepal

We are seriously concerned about the movement sparked by Generation Z youth and the recent political developments unfolding across the country. We express deep sorrow for the tragic loss of lives and damage to property during this time. We pay heartfelt tribute to all those who lost their lives, and urge the authorities to ensure that appropriate relief and fair compensation are provided to their families. We also extend our sincere condolences to the bereaved families and call for free, timely, and effective medical treatment for all those who have been injured, and wish for their full and speedy recovery.

We strongly condemn and denounce the excessive use of force during the movement, as well as the acts of arson, vandalism, and violence targeting public property, historical heritage sites, private property, commercial centers, political party offices, and various government institutions. We demand the formation of a high-level investigation commission to conduct an independent and impartial investigation into these incidents and to take strict legal action against those involved. Acknowledging that we cannot afford to repeat the mistakes made or allowed by past leaderships, it is the collective responsibility of all parties to genuinely learn from history this time. We appeal to the security forces and all concerned stakeholders to take every necessary measure to prevent such incidents in the future, protect the lives and property of citizens, and uphold peace and order in the country.

In this challenging situation, it is essential that we all exercise patience and restraint to maintain peace and stability, while protecting Nepal's sovereignty, territorial integrity, democracy, and human rights. We make an appeal to all protesting Generation Z youth, and to everyone concerned, to act with responsibility and commitment to these shared values.

Honoring the federal democratic republic system established through the hard-fought struggles and sacrifices of the Nepali people, we appeal for the formation of a government and the implementation of the rule of law within the framework of our country's existing constitutional provisions, while also addressing the demands for change and the sentiments of the Generation Z youth. Failure to do so risks pushing the country toward a deeper political crisis and internal conflict, as well as the possibility of international interference—a scenario we must all remain vigilant to prevent.

At the same time, we acknowledge the solidarity and support of our international friends, comrades, and allies, and call upon them, in this critical situation, to continue standing with Nepal in its peaceful nation-building, the restoration of democratic institutions, the promotion of peace and human rights, and the protection of civic space.
